Minutes of Meeting held on 14.06.2022

Departmental Post Graduate Committee (DPGC) meeting under the Chairmanship of Dr. M.A Shah, HOD Physics was held on 14.06.2022 at 12:30 P.M in the Conference Room of the Department. Dr. Shah (Chair) welcomed all the members/special invitees and students' representatives. **Following is the outcomes of the discussions:**

Case No.1:- (INSPIRE Candidate)

Ms. Muntha Majeed (INSPIRE Candidate): The case has been discussed in detail. As per rules of INSPIRE Fellowship (DST, GOI, New Delhi), candidate has to qualify the 2nd level for acquiring INSPIRE fellowship-2021. The committee unanimously resolved that the candidate may prepare for level -II under the supervision of Prof. M. Ikram. Once qualified, candidate can be then recommended for enrolment and registration in Ph.D. Program by u/s. For time being, she will work for her project under Prof. M. Ikram.

Case No. 2:- (CSIR-NET JRF Fellow)

Ms. Fatima Rubab (CSIR-NET JRF): Documents have been perused and Candidate has qualified JRF (Joint CSIR-UGC) under ST Category. She will get financial support from CSIR-UGC as JRF, therefore falls under the externally sponsored category. Candidate stands eligible for registration/enrolment for Ph.D. programme, as such, candidate is recommended for enrolment in the Department of Physics under the supervision of Dr. P.A Ganai, Associate Professor, Department of Physics.

Case No. 3:- (Syed Ishtiyaq)

Syed Ishtiyaq (Enrol. No: 2107PHAPHY003), a Part-Time Research Scholar under the supervision of Prof. S. Rubab has failed to submit the research proposal and other necessary statutory requirements, in time. Further in view of unsatisfactory performance, the supervisor has declined to supervise the candidate. As such, DPGC resolved to discuss the matter first with the student, therefore, HOD physics will call the concerned Research Scholar for further n/a.

Case No. 4:-

M.Sc. 4th Semester Students have to appear for final Project presentation & viva - voce which is scheduled in the Month of July, 2022. To call specialized experts for exam the list of panel members may be submitted to chair, which can be forwarded to DAA for n/a and approvals.

Case No. 5:-

As per rules, each Ph.D. Scholar both sponsored by GOI and Institute fellowship holders, has to give **08 hours per week in the Laboratory** classes. The Sponsored Post Doc's i.e. SERB/DST-Inspire/CSIR/ N- PDF awarded have also to give 8 hours per week as per rules and regulation of the institute. 


